Dear Mayor Atkinson and Council,

Mackenzie Community Services is applying for funding to bring Integrated Youth Services to Mackenzie/McLeod Lake. We would appreciate your consideration and approval of the following:

 Mackenzie Community Services with a letter of support from Foundry, will be applying for The Youth Mental Health Fund (YMHF) offering funding of up to \$500,000 per fiscal year for projects lasting up to 48 months. The funding being applied for is Federal therefore, we would have to comply with their terms of the contract if awarded funding. Foundry would guide and support as much as possible.

Integrated Youth Services is a much needed service in the community. IYS provides support services in one place for youth to access. The plan is to have a couple of private offices where youth can access virtual Foundry services. The main area will have a sitting area, entertainment area etc. It'll be a space where youth can be heard and supported as needed. We will begin as a pilot program with the hope of extending to a much larger support centre in the future.

We ask Mayor and Council to support Mackenzie Community Services with this project. We ask for a letter of support to attach to the application mentioned above. The application deadline is January 22, 2025. We kindly ask for a letter of support to be submitted to MCS by January 20, 2025.

2. Mackenzie Community Services plans to have a safe space in an area of town frequented by youth. MCS is requesting Mayor and Council to consider and approve the rental and utilization of the upper floor room in the Recreation Centre along with the washroom and office space in the back. It'll serve as a space of wellness and reset for youth 12-24 in our community.

Mackenzie Community Services is also requesting Mayor and Council to approve renovation of the back office. It is requested to add a wall in the middle of the office to make two offices. This will provide a private, confidential spaces where youth can access virtual Foundry services, receive peer support, one on one sessions etc. We are also requesting Mayor and Council to approve any additional renovations needed to make the space comfortable for our youth.

We hope that you, Mayor and Council, will support the project of Integrated Youth Services in Mackenzie for our Mackenzie/McLeod Lake youth. Writing a letter of support and approving the rental and renovations of the room on the upper floor, the bathroom and back office of the Recreation Centre will greatly assist in introducing Integrated Youth Services to our community.

Mount Milligan Life of Mine Extension

In February, Centerra Gold announced a revision to an existing streaming agreement with Royal Gold, which allows for extending the mine life of Mount Milligan to 2035 and creates the potential conditions for future mine life extension as well. The life of mine extension sits within the current mine lease boundaries for the mine. Centerra is currently working with a BC government-organized Technical Advisory Committee (TAC) to consult with government reviewers and Indigenous Nations on the permits and authorization amendment needed to extend the Life of the Mine to 2035. The schedule for this permitting process is expected to be completed in 2026, allowing a very sufficient timeline for a robust consultation process. In parallel, Mt. Milligan is also working on exploration, environmental & engineering and other works to evaluate the future of Mt. Milligan beyond 2035.

PETER PROGRAM

Pre-Employment Training & Education Readiness Program (PETER)

After several months of preparation and collaboration with the College of New Caledonia, Nak'azdli Whut'en and McLeod Lake Indian Band, we launched our seventh offering of the PETER Program.

The PETER program began on September 9th and will run until February 2025. Youth participated in a two-week Life Skills Training program, covering essential topics such as confined space safety, financial literacy, conflict resolution, and fall arrest.

Training will be followed up with a paid six-month deployment in different departments at Mount Milligan, preparing them for potential full-time employment while fostering a culture of mentorship. The PETER program underscores our commitment to training, education, and work opportunities in local First Nation communities.

ENVIRONMENT

30 YEARS OF FISHERIES STUDIES AT KEMESS

The Kemess Mine has been conducting fisheries monitoring, protection and sustainability throughout the Thutade watershed, where the Attichika Creek and Kemess Creek flows since 1994. A Fisheries Compensation agreement (FCA), created in 1996, initiated a long-term monitoring program designed to evaluate the success of habitat compensation measures. The agreement, signed by the Department of Fisheries and Oceans, the British Columbia Ministry of Environment and Kemess Mines Inc., has the objective of no net loss of the productive capacity of the waste rock/open pit area creeks.

By 2014, the Kemess Mine completed the habitat compensation features outlined in the FCA, including the construction of a fish ladder to facilitate upstream fish access. Since 2018, Chu Cho Environmental, a company owned by the Tsay Keh Dene Nation, has been actively monitoring the effectiveness of these fisheries' compensation projects. The primary species studied are Bull Trout and Dolly Varden. Overall, juvenile fish studies have demonstrated significant success, showing that fish density for both species is above average, and spawning bed counts have shown a consistent upward trend, nearly doubling over a six year period.



RE: Protecting Taxpayers from Overspending on Local Government Construction

Dear Mayor and Council:

The Independent Contractors and Businesses Association (ICBA) is Canada's largest construction association and a leading industry organization in British Columbia, with more than 4,500 member and client companies. ICBA's B.C. corporate members account for approximately 85% of the province's construction sector – representing more than 190,000 jobs. Construction itself is one of the biggest B.C. industries, directly generating almost 8% of GDP. ICBA also owns and manages a rapidly growing employee health and dental benefits business which currently supports more than 300,000 Canadians.

Apart from advocating for the interests of construction companies and contractors, ICBA is a principled voice for free enterprise and the benefits of a competitive, market-based economy. Unlike many other business associations, ICBA receives no funding from governments at any level. We believe that competition and choice for consumers and taxpayers is by far the best way to deliver value-for-money and create the conditions for a thriving economy.

ICBA is writing to you and other B.C. local government bodies to share our views on the topic of public sector procurement. At a time when large numbers of British Columbians are facing affordability challenges, many small and mid-sized businesses are struggling to survive, and the B.C. government is running record budget deficits, we believe it is **important for municipal leaders to commit to open, fair and transparent procurement practices** across all domains of local and regional government activity. This includes the regular purchase of goods and services to operate local government as well as procurement that is tied to capital spending and the development and maintenance of infrastructure assets.

When municipalities pay for goods, services and capital projects, they do so on behalf of all taxpayers in the community. Municipal policymakers have an obligation to adopt prudent fiscal policies and to ensure the best possible value-for-money when expending taxpayer dollars. Competitive procurement policies are a vital part of delivering on this fundamental obligation.

Across Canada, local government expenses amounted to \$220 billion in 2022, with the main components of expenditures consisting of purchases of goods and services, employee compensation, subsidies and grants, interest payments on debt, and the depreciation of fixed capital (Statistics Canada, Table 10-10-0015-01). In the same year, total local government revenues were \$225 billion, of which the largest shares were grants/payments from other levels of government and revenues derived from taxes on property.

In the past few years, the B.C. government has undertaken a significant fraction of its capital projects under the "Community Benefits Agreement" (CBA) framework adopted in 2018. Under this policy, a provincial Crown Corporation (British Columbia Infrastructure Benefits Inc. – BCIB) contracts for the employees required to build certain public sector infrastructure and other capital projects. It does so through an agreement with a group of 19 trade unions that are part of the broader Building Trades Union (BTU) alliance. All employees working on CBA projects must be (or become) members of an affiliated BTU.

This very unusual arrangement dilutes the important relationship that exists between an employer and its employees across the rest of the B.C. private sector.

The province's CBA policy has the effect of <u>restricting bidding</u> on projects covered by the scheme. This is especially problematic given that about 85% of the people working in the B.C. construction industry are not BTU members nor employed by contractors which are covered by BTU collective agreements. Fewer bidders means less pressure to ensure competitive costs and excellence in project delivery. Many ICBA members will not bid on public sector projects covered CBAs because of the extra bureaucracy and administrative complexity involved and also because they do not wish to give up control and management oversight of their own workforce – as is the normal practice in Canadian business.

As demonstrated by academic research, **restricted bidding translates into higher costs for taxpayers** and the users of infrastructure services established via CBA-type arrangements.¹ Cost over-runs and unexpected delays are a common theme with CBA projects.² The net result is hundreds of millions of dollars of additional costs imposed on the B.C. taxpayers and delays in project delivery.

It is sometimes argued that restrictive tendering policies like CBAs are necessary to support local hires, apprenticeships, and pensions. In a labour shortage like B.C. construction is facing, our companies do everything they can to hire and keep local workers. ICBA is the single largest sponsor of trades apprentices in British Columbia, and open shop contractors train 82% of all apprentices in the province. When it comes to financial security, ICBA contractors and their employees utilize RRSPs, bonus programs, and profit-sharing initiatives, providing flexible and effective solutions tailored to their workforce, rather than being restricted to union-controlled pension plans.

For local governments, the lesson from B.C.'s failed experiment with CBAs is clear. **Municipal and regional government projects should be developed and managed using open, competitive procurement.** Restrictive tendering should be avoided in all areas of local government activity – capital projects, but also the day-to-day procurement of goods and services. Municipalities should not discriminate against B.C. businesses and their employees based on factors such as particular union affiliations.

Dear Mayor Atkinson,

Westcoast Energy Inc. (Westcoast), an Enbridge company, would like to provide you with an update regarding the proposed Sunrise Expansion Program (Project).

As you know, on May 30, 2024, Westcoast filed an application with the Canada Energy Regulator (CER) for approval to construct and operate the Project. Since filing of the application, certain refinements to the Project scope have been made following feedback from Indigenous groups, landowners, stakeholders and other interested parties, as well as additional archaeological, geotechnical and environmental studies. These scope refinements are reflected in a Project update filed with the CER on January 6, 2025. Specifically, the Project update describes the following refinements to the Project scope since filing the Application:

- Westcoast is proposing an alternative, shorter, route for the powerline that will supply compressor station (CS)-8A (Kingsvale) with electricity.
- Westcoast is proposing to remove from the Project scope the powerline that was proposed in the Application to supply CS-8B (Othello) with electricity, instead relying on BC Hydro to upgrade its existing powerline infrastructure to supply electricity to CS-8B.
- Westcoast is proposing to decommission, by removal, a short segment of existing deactivated pipeline within the existing Westcoast system right-of-way within the proposed CS-3 (McLeod Lake) CS-4A (Summit Lake) loop.

These scope refinements demonstrate Westcoast's commitment to incorporating local knowledge and reducing impacts to Indigenous rights and environmentally sensitive areas to build a better Project, while also building lasting and productive relationships with Indigenous groups and local communities.

BACKGROUND:

THAT Council awards the purchase of a Fork Attachment to Nors Construction Equipment Canada GW Ltd in the amount of \$16,010 plus GST.

BACKGROUND:

The District's existing Forks attachment is used for unloading and loading equipment/supplies from delivery trucks, as well as moving equipment/supplies around the public works yard. The Forks have been previously repaired, and each time is degrading the integrity of the equipment. Following a safety inspection in November 2024, deficiencies were brought forward to staff's attention and the equipment was tagged out of service due to safety concerns. Since that time, there has been no forklift to handle materials, supplies or equipment that need to be moved, loaded or unloaded.

The District would need to purchase as soon as possible to ensure that unloading and loading of equipment/supplies can be done using proper safety measures.


SUMMARY:

This replacement is not identified on Schedule D of the 5-year financial plan, so staff are requesting pre-approval from Council to purchase the fork attachment before staff enter into provisional capital budget discussions later this month. If staff wait until the provisional capital budget is approved in early February, then there is no way of loading/unloading heavy materials, and a contractor would need to be hired to complete the task. The estimated delivery time is 4-6 weeks from date of order.

The new unit can attach to any of the existing loaders and can be changed out quickly with the operator not required to leave the loader, enhancing the safety aspect of the changeover.

AND THAT Council directs staff to submit resolutions to both the NCLGA and UBCM advocating for a review of the Clean Energy Act, specifically to study the feasibility of a reversal on the current prohibition on nuclear energy in British Columbia.

BACKGROUND:

Rationale:

- 1. The District of Mackenzie has declared a climate emergency, as have numerous other municipalities across BC. Nuclear Energy is a GHG free source of electricity.
- BC Hydro has put a call out for electricity production, the first time it has done so in over a decade. This is on top of the new electricity production coming online from the Site C Damn and the announced twinning of the Highway 16 Northwest Electricity Corridor. The province needs mor electricity, full stop.
- 3. The District of Mackenzie is in an ideal location to be home of Nuclear Energy in British Columbia. We are

i) ideally located close to existing electricity corridors,

ii) directly beside Williston Reservoir, an already BC Hydro controlled body of water, iii) a plethora of land,

iv) an economy hurt by the downfall in forestry looking to diversify,

v) distance from the seismically unstable/risky coastal regions

Subject:	Williston Lake Elders Society – Land Request Review

RECOMMENDATION:

THAT Council receives this report for information.

BACKGROUND:

At the Regular Meeting of November 12, 2024, the Williston Lake Elders Society (WLES) presented their plans to pursue funding toward the design and development of a seniors housing and care complex. They requested support by way of donation of the land where the Ernie Bodin Community Centre is located. Council requested staff bring back a report with an estimated value of the land and further information.

Authority:

Section 26 of the *Community Charter* authorizes Council to dispose of its land or improvements subject to certain requirements depending on the type of land being sold, donated, or exchanged and who the land may be given to. In this case, Council is authorized to gift the land to the WLES subject only to notice requirements under Section 24 of the *Community Charter*.

Technical Review:

A high-level technical review for the proposed use of the land has been attached for Council's consideration. A map depicting an example of what the proposed new lot could look like at that property has also been attached.

Land Value: \$126,470	This estimate is derived from the 2024 appraisal of the District- owned Downtown Commercial Lot 2 (\$125,000 / 1.25 ha), located near the Community Bike Park.
	\$125,000 / 1.275 ha = \$98,039/ ha 3.19 acres = 1.29 ha 1.29 ha x \$98,039 = \$126,470



Development Requirements:

Whether District-initiated or applied for by the WLES, the subject property would require the District to go through both a subdivision and zoning amendment process as outlined in the District's Development Procedure Bylaw 1369, 2017. A sale or lease agreement, with any associated covenants, would also be required to be finalized for transfer of title or use of the land.

Subdivision Process

The subdivision process would take approximately 4-5 months and would require at minimum, surveying, a utilities/servicing review, and a legal review and registration. The anticipated cost to go through this process, based on a subdivision that occurred in 2024, is ~\$15,000. The subdivision application fee is \$250. Council has the option to waive all these fees.

Zoning Amendment Process

A zoning amendment would be required because the proposed site is currently designated with two different zoning classifications: PI (Public Institution) and RM2 (Multi-Family Residential 2). This split zoning means that different land use regulations apply to different parts of the site, which may create conflicts regarding what types of development or uses are permissible. In order to proceed with a housing project, the zoning of the site must be unified or adjusted to allow for consistent land use regulations across the entire area.

This process could take up to 2-3 months, depending on agency referral feedback. The cost for a zoning amendment application is \$500 plus advertising costs. Council has the option to waive these fees.

Sales Agreement Process:

The District has template sales agreements for land donation and would work with our legal representatives to work with the WLES and tailor the agreements as necessary. The process could take 2-3 months.

The Williston Lake Elders Society has requested the donation of the land in 2024, however noted in their presentation that there would be no development itself for 5-10 years. Due to the central location of the property and the high public use of that area, staff would recommend adding subjects to any sale or lease documents that would:

- Provide assurance to the WLES that the land would be transferred, which would help with accessing grant funding;
- Allow time for the District to demolish the Ernie Bodin Community Centre;
- Preserve public use of the area during the period following the demolition and that of development beginning; and



- Have it formally appraised

Additionally, if the property title were to be gifted to the WLES, staff would recommend the registration of a "Right of First Refusal" covenant on the property, in that if there is lack of development in a certain timeframe, the society dissolves, or there is an offer to sell the property, that the District would have first right to property. It would be recommended any long-term lease would have similar termination language.

BUDGETARY IMPACT:

If Council chose to waive the subdivision and rezoning fees, the \$15,000 plus permit fees would be funded through the General Operating Budget.

The appraised value, once finalized, would be recorded as a loss on disposal and be reflected on our financial statements.



4.1 MACKENZIE RECREATION CENTRE SITE RECOMMENDATIONS

The recommendations for the Mackenzie Recreation Centre Site (East Anchor) has four interconnected areas that will be built over three phases. The design focuses on adding more recreational opportunities in the public facing yards of the recreation centre.

The initial phase focuses on the entrance to the building and the creation of a public plaza adjacent to it. This plaza will feature public artwork, a splash pad, and a multi-functional covered area suitable for use as a small stage or a viewing area for Phase 2. This area will be equipped with flexible seating and fire pits.

Phase 2 proposes the development of a multi-use

rink. This versatile space will function as a lacrosse pitch and a large concert venue in the summer, and will become an ice rink during the winter months.

Expanding on Phase 2, Phase 3 introduces a gravel walking path for summer that can be flooded and transformed into a skating loop during the winter. Additionally, Phase 3 includes a picnic area and community garden with a sheltered space. There are also a couple of optional items that may be included in this phase. These include the redevelopment of the existing dog park and ice rink located behind the Mackenzie Recreation Complex.


Figure 21. Splash Plaza (Hapa Collaborative, 2021).

Subject:	Dental Equipment – Storage and Disposal

RECOMMENDATION:

THAT Council authorize Administration to dispose or recycle District-owned dental equipment that is no longer in useable condition.

BACKGROUND:

At the Regular Meeting of April 11, 2022 Council authorized the storage of the District's dental equipment at the Town Centre Mall with the intention of offering the dental equipment to any prospective dentist looking to provide services within the community.

In December 2023, staff were approached by Darcy White, owner of Town Centre Mall, about a partnership in helping a prospective dentist, Dr. Yulirussi, open a clinic in Mackenzie. The District's contribution requested was to allow Dr. Yulirussi use of several pieces of the District's available dental equipment. An equipment use agreement was approved. Dr. Yulirussi later gave notice and ended the agreement on June 30, 2024.

Darcy White has allowed the District to continue storing the equipment in one of the Town Centre Mall units. The unit that the equipment is in is going to be rented and Mr. White has asked that the District move the equipment into another unit.

In conversation with Dr. Yulirussi previously, it was noted that much of the equipment was no longer in a condition that it could be used effectively in a practice or put back together. He only used a few of the pieces that we had in possession.

Rather than moving the equipment to another unit for storage, staff are recommending its disposal and only retain the pieces that are still in working condition.

BUDGETARY IMPACT:

There would be a loss on disposal of \$46,320 based on a 2022 Dental Equipment Appraisal that was completed prior to the demolition of the Dental Clinic Building.
