Janice Nelson, the Macktown Buzzette, noted that the total request for funding to update the Municipal Website are about \$100,000. She asked if the District would utilize that entire amount. Emily Kaehn, Director of Corporate Services, explained yes, quotes the District has received are in the area of about \$80,000. There are additional features that could be used if the budget needed to be higher. The District is hoping to have the project funded completely and are applying for multiple streams in case one or more are unsuccessful. Mayor Atkinson responded that trails and sidewalks within District boundaries are something the District should be aware of when it comes to maintaining and repairing.

# Fraser-Fort George 9-1-1 to take over answering 9-1-1 calls

The way 9-1-1 calls are answered in the Fraser-Fort George, <u>Bulkley-Nechako</u>, <u>Cariboo</u> and <u>Kitimat-Stikine</u> regional districts is changing.

Starting in 2026, Fraser-Fort George 9-1-1, a service provided by the Regional District of Fraser-Fort George, will answer the four regional districts' 9-1-1 calls, determine the nature of the emergencies and transfer callers to police, fire or ambulance dispatch centres as required.



"Fraser-Fort George 9-1-1 will provide our partner regional districts with a more autonomous 9-1-1 call answer service that can respond to the needs of northern communities and residents," says Lara Beckett, Chair of the Regional District of Fraser-Fort George.

The regional districts have had a contract with Vancouver-based **Emergency Communications for BC Inc.** (**E-Comm**) to answer 9-1-1 calls since 2014. When Fraser-Fort George 9-1-1 takes over this role next year, 9-1-1 calls will be answered in Prince George for these four regional districts.

"Bringing the 9-1-1 call answering service back to north central BC will create new job opportunities and economically benefit the region," says Mark Parker, Chair of the Regional District of Bulkley-Nechako.

"As our 9-1-1 call answer costs continued to increase, we needed to identify a more financially sustainable option for our residents," says Margo Wagner, Chair of the Cariboo Regional

District.

In 2024, a total of 104,476 9-1-1 calls were made in the regional districts, with 47,671in the Regional District of Fraser-Fort George, 23,013 in the Cariboo Regional District,19,591 in the Regional District of Kitimat-Stikine and 14,201 in the Regional District of Bulkley-Nechako.

"We look forward to Fraser-Fort George 9-1-1 being able to apply local knowledge and provide a better experience for our residents when they need emergency services," says Cyra Yunkws, Chair of the Regional District of Kitimat-Stikine.

When Fraser-Fort George 9-1-1 takes over the call answer service, calls will continue to be transferred to the same dispatch centres as under E-Comm. #### BC Bats Show No Sign of Infection from White-nose Syndrome – Public Asked to Report Dead Bats

Mackenzie, BC - The BC Community Bat Programs, in collaboration with the Province of BC, are asking the public for help in the effort to detect and prevent the spread of white-nose syndrome (WNS) in bats. Residents are urged to report any bat activity observed in winter and any sick or dead bats found before May 31<sup>st</sup>.

There have not been any bats with WNS found to date in BC, but *Pseudogymnoascus Destructans* (Pd), the fungus that causes the disease, was confirmed in 2022 in the Boundary Region. Recently, the B.C. Ministry of Water, Land and Resource Stewardship released results from 413 samples taken last winter and spring, and they all came back as negative. "This was surprising, but great news, as bats with WNS have been confirmed in Alberta and in northern Washington State, just south of the border," says Tina Watters, Omineca coordinator for the BC Community Bat Programs.

First detected in New York State in 2006, the disease continues to spread, with detections in northwestern and central Washington and in south-central Alberta. The fungus does not cause disease in humans and pets, but WNS has devastated North American bat populations. The fungus attacks bats while they are hibernating, growing on their faces to give an appearance of a white nose. Bats often wake to clean the fungus from their skin. This uses valuable energy, and eventually the bats die from starvation.

"Across North America, millions of bats have been killed, and seven of our 15 BC species could be severely affected by the disease," says Watters. The Little Brown Myotis and the Northern Myotis are both listed as Endangered in Canada due to WNS. Though there is not yet a proven cure for WNS, several promising treatment options are being developed, and it may be possible to mitigate the effects of this wildlife health crisis.

If you find a dead bat or have sightings of winter bat activity, please report to the BC Community Bat Programs online at <a href="www.bcbats.ca">www.bcbats.ca</a>, via email at omineca@bcbats.ca or by calling 1-855-922-2287 ext. 26. All live bats should be left alone — keep your distance, snap a photo and report it to the BC Community Bat Programs. If you must move a bat, visit <a href="www.bcbats.ca">www.bcbats.ca</a> for advice and never touch a bat with your bare hands. Please note that if you or your pet has been in direct contact with the bat you will need further information regarding the risk of rabies to you and your pet. Contact the BC Community Bat Programs for more information. "The more bat reports from the public that we receive, the better we can understand how WNS might spread and affect local bat populations," says Watters.

"The bats of BC are key predators of many night-flying insects. They are essential parts of BC's ecosystems and provide a huge economic benefit by helping control agricultural, forest, and urban pests," says Watters. In partnership with the BC Ministry of Water, Land and Resource Stewardship, the BC Community Bat Programs provide information and promote local stewardship and citizen science. The programs are supported by funding from the Habitat Conservation Trust Foundation, Forest Enhancement Society of BC, the Habitat Stewardship Program, and the Province of BC. You can find out



# Northern Healthy Communities Fund (Northern Development Initiative Trust) Deadline: Ongoing

If your community is nearby an LNG Canada or Coastal GasLink project, apply for the Northern Healthy Communities Fund to help manage the economic growth from major development projects.

# **Secondary Suite Incentive Program (BC Housing)**

#### Deadline: Open until funding is exhausted

With the <u>Secondary Suite Incentive Program</u>, homeowners can get up to 50% of renovation costs (up to \$40,000). This funding helps develop a secondary suite rented below market value for at least five years.



### Transit Minor Betterments Program (Government of BC)

#### Deadlines: Open until funding is exhausted

Public transit helps people access jobs and education, especially those with transportation challenges. Apply for up to \$100,000 for projects that improve the transit experience. These projects can include bus stop shelters, lighting, accessibility improvements, and signage. Local governments, First Nations communities or organizations, and non-profit organizations are encouraged to apply. Projects must be completed by March 31, 2025.

#### **BACKGROUND:**
