Community Policing:

In line with the APP initiative for Crime Prevention through Curfew Compliance checks, the Mackenzie RCMP members were vey active in conducting curfew and house arrest checks on local residents on conditions. (Currently there are four curfew checks)

Victim Services July 2023 stats:

Ongoing Clients - 32 New Clients - 5 Closed Clients - 8

Incidents resulting in Victim Services assistance - 3

Referral Sources - Police.

New clients included: 3 females and 2 males. Of these clients: 4 are adults and 1 is a youth.

Incident Types: Youth Sexual Assault/Abuse, Other Assault/Abuse, and Sudden Death.

This month was a slower month for Victim Services. There was no court in Mackenzie this month, so a lot less court updates were given. A few clients had files that had court dates in Prince George or Tsay Keh Dene and those clients received court updates. Clients have been noticeably harder to get hold of this month, but I believe it is just due to summer holidays. Victim Services completed two online learning courses, which included: Government of BC Victim Services Training - Child & Youth Safety Planning as well as Walking the Urban Path to MMIWG2S+ Action Plan Implementation. There is now a Community-Based Victim Services Worker in Prince George who works along with the Elizabeth Fry Society, and I was able to reach out to her. I am hoping to coordinate with her for additional resources for domestic violence victims in Mackenzie.

- 1. CONVICTIONS (Out of town court)
 - a. A non local female was found guilty of Uttering Threats she received 1 day jail
- 1. File Summary In July 2023 Mackenzie RCMP responded to 198 files. The Mackenzie RCMP completed 7 proactive road checks. Mackenzie RCMP noted an increase in bear calls.. Mackenzie RCMP continue to engage Conservation with bear calls. Investigations of Interest:
 - 1.1. On 2023-07-02 Mackenzie RCMP were conducting a check stop in Mackenzie when they noted a driver was displaying signs of intoxication. Police completed a mandatory breath sample road side to which the driver produced a sample of their breath resulting in a "fail". The driver was suspended from driving and the vehicle was impounded.
 - 1.2. On 2023-07-05 Mackenzie RCMP responded to a report of a suspect breaching their Undertaking conditions. Police arrested the male who was held for court and later released for a court date in Mackenzie.
 - 1.3. On 2023-07-04 Mackenzie RCMP responded to a report of a sexual assault. Police obtained multiple statements from witnesses and the victim. The suspect was arrested and later released with conditions in place to protect the victim. RCMP believe this to be an isolated event with no risk to the public at this time. The suspect is to appear in court in Mackenzie in August.
 - 1.4. On 2023-07-06 Mackenzie RCMP responded to an assault in progress. Police attended the business and spoke to the employee who provided a statement. Members arrested the suspect who was released by police on an undertaking with conditions to protect the victim and to attend court in Mackenzie.
 - 1.5. On 2023-07-22 Mackenzie RCMP responded to a report of a loud explosion in McLeod Lake. Members attended with Fire and Rescue and it was determined that lightening had hit a shed in a backyard.
 - 1.6. On 2023-07-23 Mackenzie RCMP responded to a report of a theft from a local business. Police attended and identified the suspect. The suspect was located and returned to the business to pay for the merchandise. Both parties cooperative with police and no charges being pursued.
 - 1.7. On 2023-07-26 Mackenzie RCMP attempted to pull over a vehicle that fled from police. Another officer was able to relocate the vehicle and stop it. The suspect driver was not local to Mackenzie and received fines under the motor vehicle act. The vehicle was impounded under the motor vehicle act.
 - 1.8. On 2023-07-29 Mackenzie RCMP stopped a vehicle travelling beyond the posted speed limit in Mackenzie. Police noted a driver was displaying signs of intoxication. Police completed a mandatory breath sample road side to which the driver produced a sample of their breath resulting in a "warn". The driver was suspended from driving and the vehicle was impounded.
 - 1.9. On 2023-07-29 Mackenzie RCMP responded to a report of an impaired driver. Police located the suspect vehicle. Police noted a driver was displaying signs of intoxication. Police completed a mandatory breath sample road side to which the driver produced a sample of their breath resulting in a "Fail". The driver was suspended from driving and the vehicle was impounded.
