**Detachment Case Load:** 

November 2023, the Mackenzie RCMP investigated 170 Files (185 files for November 2022)

- 17 Crimes against a person files
- 17 Crimes against property files
- 13 Other Criminal Code violations
- 1 Narcotic Control Act
- 18 Provincial Statute / Federal Statute
- 102 RCMP / Municipal Statute
  - 2 Traffic Violations

(8 files were unfounded, 7 files resulted in charges)

- There were 8 Prisoners Lodged in Cells for November 2023 - On going Guard Shortage
