BACKGROUND:

The Access and Inclusion Advisory Committee (AIAC) is a Select Committee of Council established to provide advice and recommendations to Council on matters relating to citizens with disabilities, seniors and other citizens with access issues that may impede participation in everyday aspects of community living.

The AIAC mandate is as follows:

- a) To inform all citizens of the Committee's purpose and to identify existing social and physical barriers.
- b) To provide advice and information in regard to future planning of municipal services, programs and facilities.
- c) To work with Council to increase public awareness of the issues of accessibility and inclusion for people with disabilities, seniors, and all citizens.

1st Quarterly Activity Report

Over the last few months, the committee members have been actively involved in working with a variety of groups and attending workshops when the opportunities present themselves. All committee members take every opportunity in our daily lives whether it be at work or when participating in an activity or attending an event the Accessibility and Inclusion Committee members are advocating for all persons faced with barriers that impede the quality of their life. We look forward to any opportunity that allows us to speak about our role in the community and we listen to our audience as to any concerns or recommendations that they may share. We continue to offer our "Walk and Roll" courtesy site inspections, offer on-on-one conversations,



visits to workplaces, group discussions with small groups or staff, and provide recommendations to businesses for funding, recommend changes to the existing environment, and any other resources that seem pertinent to the situation. We are always on the lookout for barriers that may impede access and inclusion for all. We are always watching and listening for ways that our committee can be of assistance in making Mackenzie an Accessible and Inclusive Community.

Since introducing the Kate Milne Action Plan to Council in January we are trying to find the recommended "linkages" in the report that we can support and action quickly and efficiently. We are forming relationships with service groups and organizations that serve have a similar vision and/or cause i.e. Mackenzie Seniors, Better at Home, Mackenzie Community Arts, Mackenzie Community Service, and the Age Well at home projects, designed for seniors and other vulnerable populations.

On January 5 the committee (not including district representatives) met to review the council presentation booked for January 8 and during this meeting there was discussion about the quarterly meetings being long and cumbersome with long agendas. It was decided to propose to the district that we meet every other month on the third Wednesday at 3:00 pm. At the first meeting we agreed to try this format and try to keep our meetings to one hour in length. Additionally, we were made aware that Councillor Brumovsky would be the new alternate council liaison in addition to Councillor McMeeken. We agreed to and are still trying to bring our meetings to a one-hour format and then move to a lunch hour timeframe. The one-hour time lunch time frame may also allow for other community groups to attend our meetings as well.
